

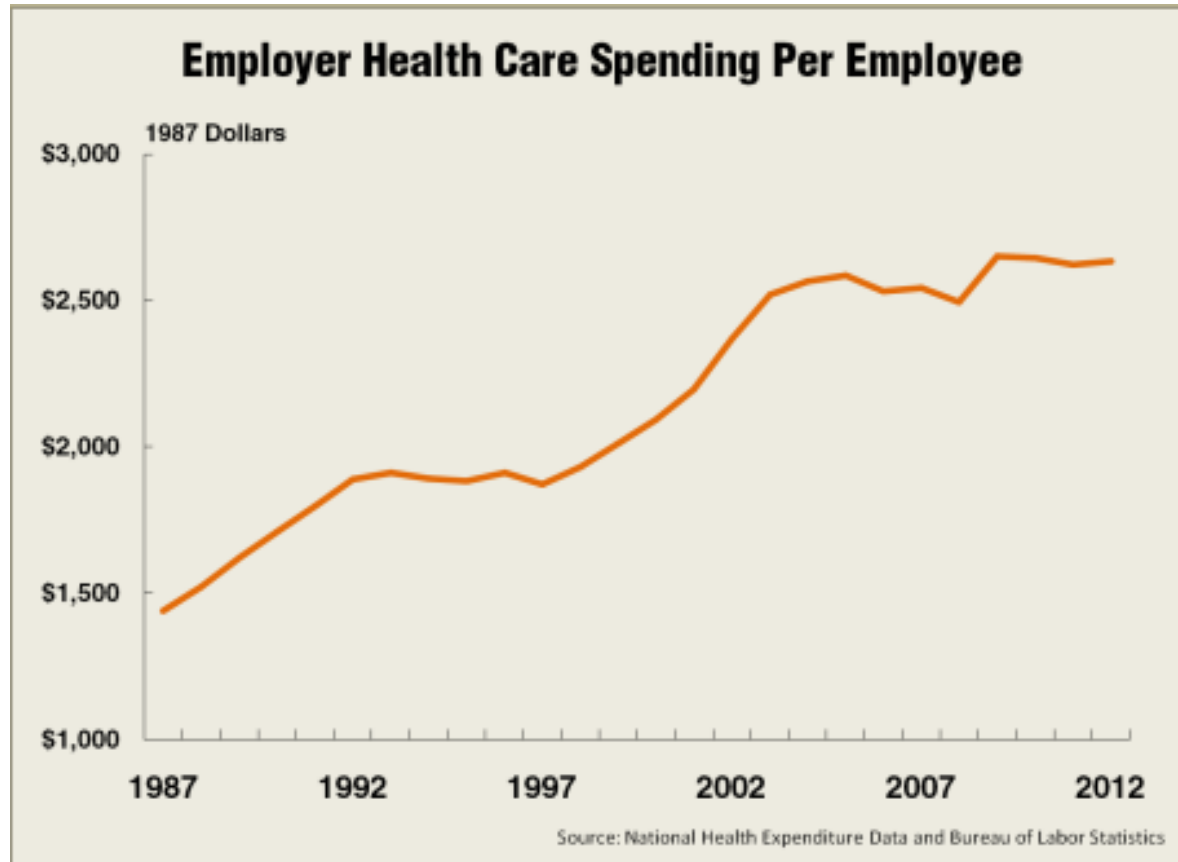

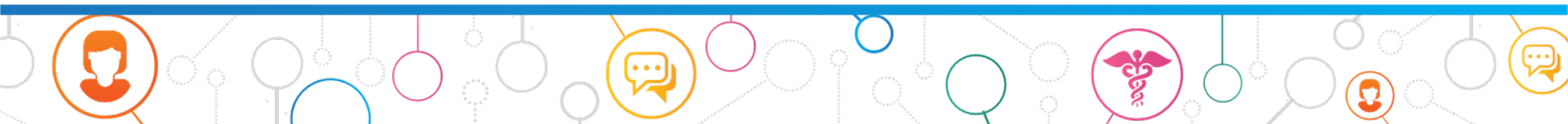

CPHCC – The Beginnings

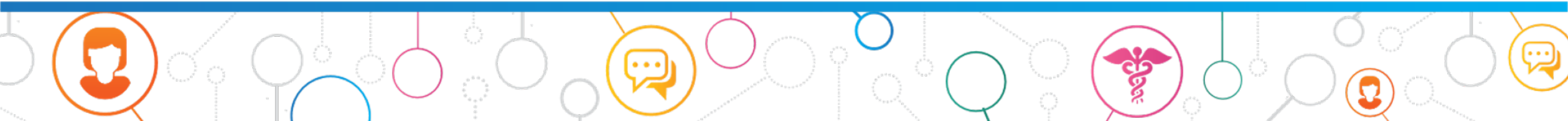


In the early 1990's, representatives from Labor, Management, and a number of healthcare professionals met for the purpose of creating an organization that would coordinate efforts and create mechanisms to control health care costs in an environment that had experienced rapidly rising health insurance costs.



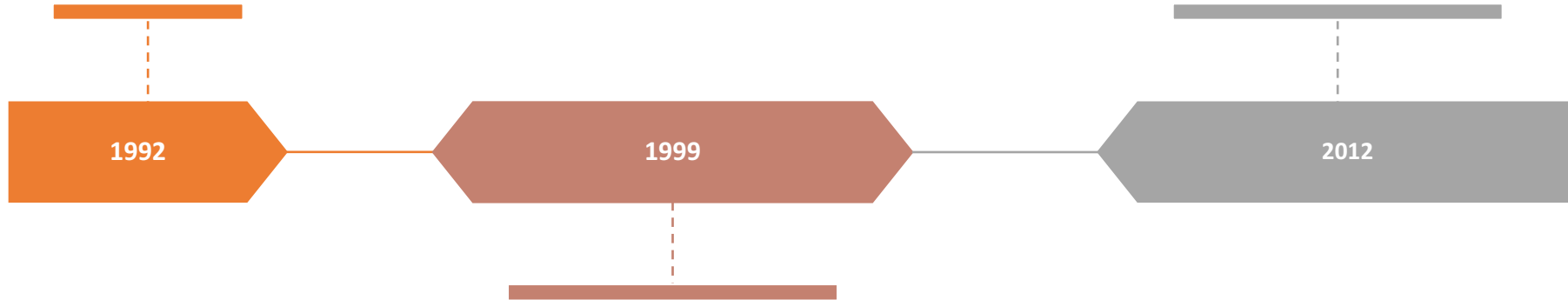
CPHCC – The Beginnings

In 1992, representatives from CTA, CSEA, and five Trust Funds (Shasta, BASIC, SCEET, VEBA, Gold Coast Trust and Monterey Bay) met at CTA headquarters and agreed to form the California Public Employers-Employees Trust Fund Group (CPEETFG).



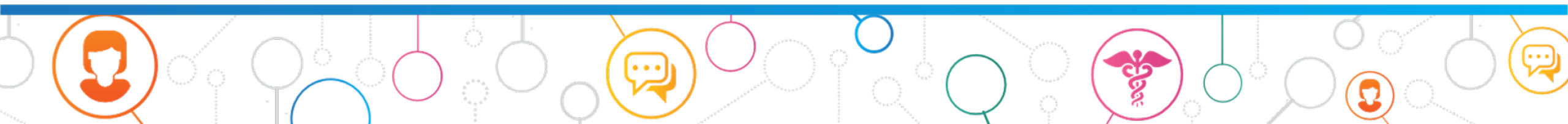
Earlier Names for CPHCC

The California Public Employers-Employees Trust Fund Group (CPEETFG) was formed in 1992.



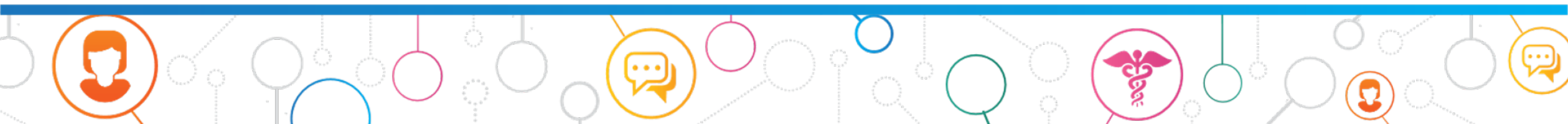
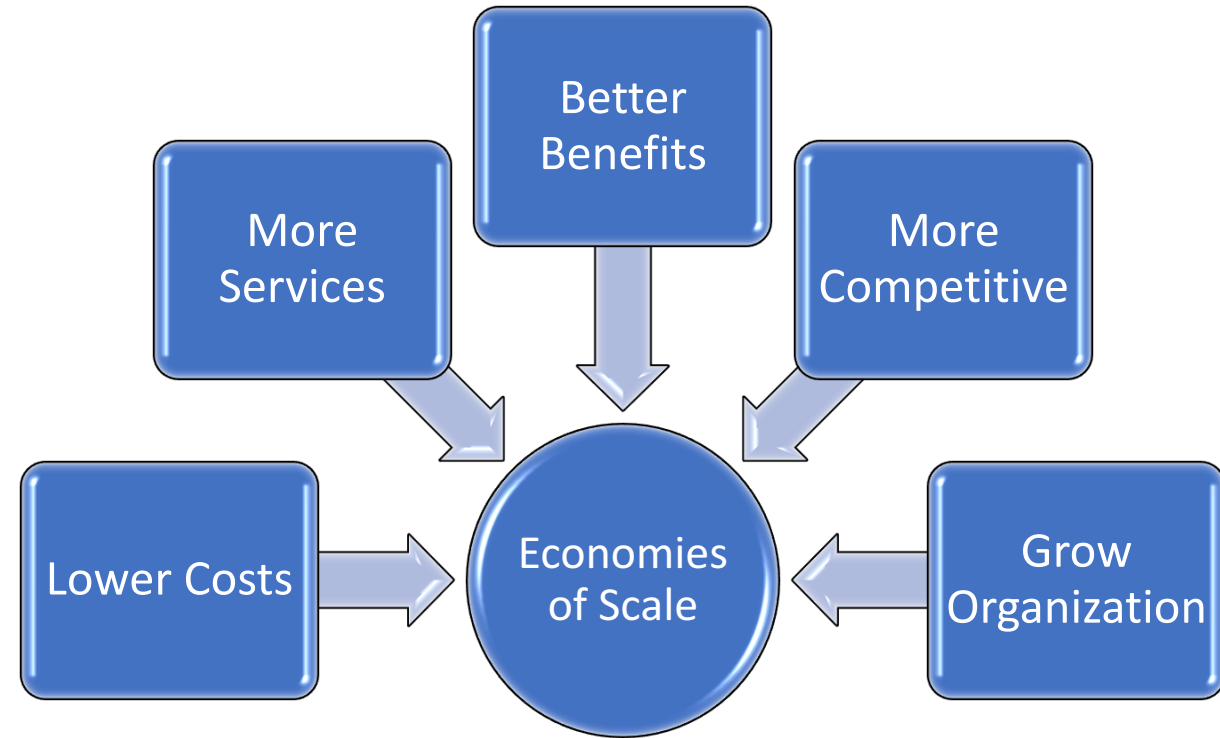
In 2012, CPEEHCC changed its name to the California Purchasers Health Care Coalition (CPHCC) to allow public and private sector membership with Joint Labor & Management Boards

In 1999, it changed its name to the California Public Employers-Employees Health Care Coalition (CPEEHCC) to allow members from all public agencies such as cities, counties, etc.

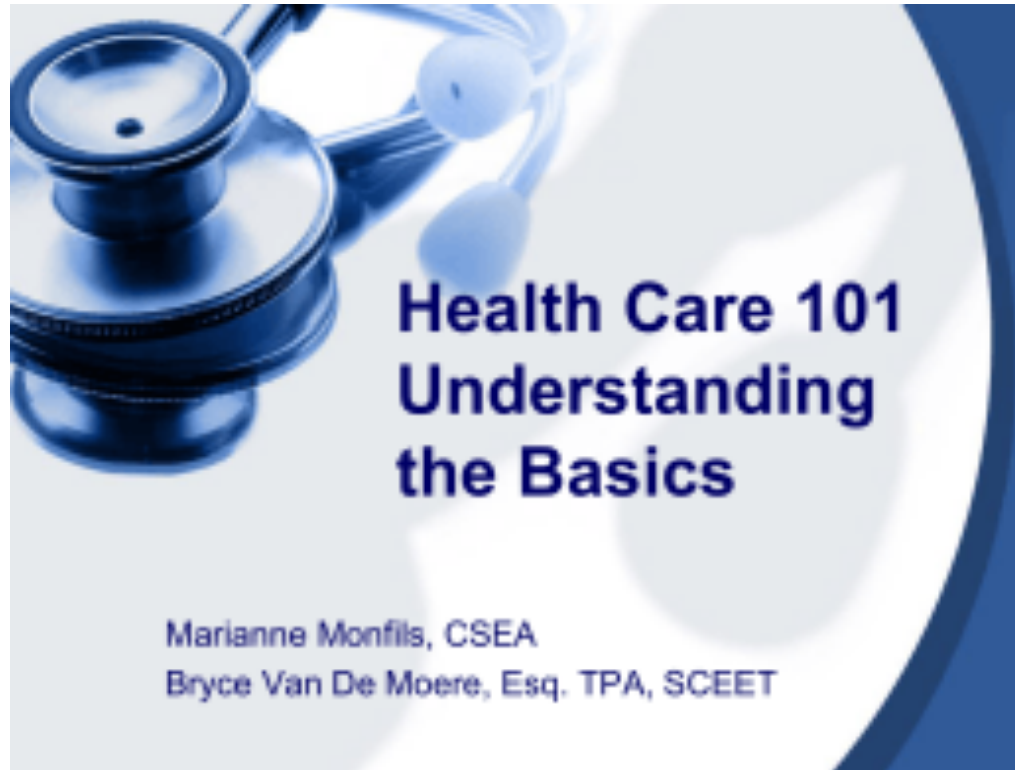


CPHCC – Its Mission

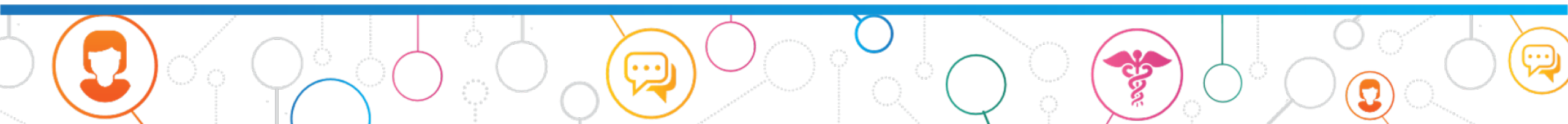
CPHCC was formed to use the combined numbers of the member Trust Funds and apply the economies of scale to generate better rates and benefits for the Trust Funds and its constituents...school districts and their employees.



CPHCC – Its Mission



In 1995, CPHCC expanded its mission to include educating Labor and Management for the purpose of assisting both to become better informed about healthcare when making decisions about employee health benefits.

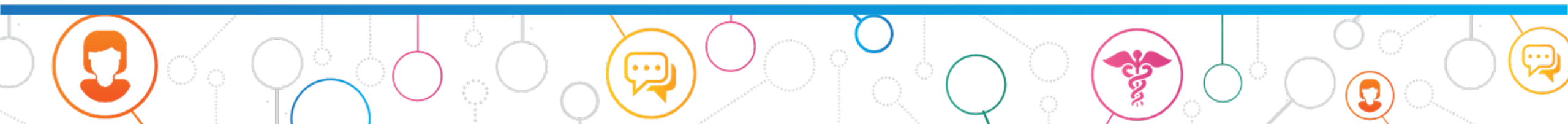
WHAT IS THE NLAHCC?

- A national alliance of Taft-Hartley & public sector labor management coalitions formed in 1996
- Non-profit 501(c)(5)
- Created to advance the health care coalition concept
- 22 member coalitions
- Over 6 million covered lives represented



California Health Care Coalition

- Representing more than 4 million Californians
- CHCC is a membership organization of public and private sector employers, unions and health and welfare trust funds
- CHCC is determined to use collaborative means to improve health care quality and reduce costs without reducing benefits
